#### BEHIND-THE-HEAD ELECTRONIC HEARING PROTECTION



### **DEVICE FIT**

## Selecting foam ear bud size:

The Stealth 28 comes with three sets of foam ear buds, small, medium and large. Select the size you feel will best fit snugly into your ear canal. Slide the foam ear buds onto the stems of the device until the foam fully covers the stem. Test the fit of the ear buds prior to exposure to loud sounds. It is recommended to wear the largest size ear bud that comfortably fits your ear canal. Wearing too small of an ear bud may result in sound leaking around the ear bud and not receiving full hearing protection.

# Wearing the headset:

With the unit turned off, wrap the stealth 28 around the back of your head and hook each of the curved ear hooks over your ears. Gently insert the ear buds inside the ear canal until they are fully seated. Shake your head, side to side, to ensure the ear buds will not disengage from the ear canal.

# **DEVICE FUNCTIONS**

# Turning the device on:

Slide the Power Switch to the ON position. The LED will be illuminated green if the headset is charge and the unit is ON.

# **Changing Ambient Sound Volume:**

Volume changes respectively when pressing the Ambient Volume Up or Down controls:

- ••Up increases volume by one stage.
- Down decreases volume by one stage.

There are five levels of volume adjustment up to when Ambient Volume reaches maximum Sound Level (Sound level 9/+14dB)



## Charging the device:

Slide the power switch to OFF position. Open the Micro USB Connector cover and plug in a Micro USB cable to it and plug the other end of the cable into a USB power source or adapter. While the device is charging the LED will be blinking RED. When fully charged the device's LED will turn off.

NOTE: When device is in the OFF position, the ear buds will still provide passive noise attenuation.

## CAUTION

- The earbud supplied with your Pro Ears Stealth 28 is used to reduce harmful loud sounds like gunshot noise.
- Gunfire is a hazardous exposure noise. Altus Brands carries no implied guarantee for over-exposure to noise.
